WHO DOES WHAT?

COUNTY COUNCILS carry the main responsibility for damage caused by wildlife in their counties. Questions regarding preventive hunting of predatory species, subsidies and compensation should be sent to them.

THE WILDLIFE DAMAGE CENTRE answers questions of a general and practical nature, as well as questions to county councils.




EXAMPLES OF PROTECTED WILDLIFE

NEW REGULATIONS

As of 1995, there are new regulations regarding reimbursement for damage caused by wildlife. The new rules apply only to damage caused by protected wildlife. The basic principle is that measures should be taken to prevent damage, primarily by hunting. Financial assistance is available for using other damage prevention measures in situations when hunting cannot be applied. It is possible to apply for compensation for damage caused by wildlife and which could not be prevented.
